How much will my application cost?

The following fees are current as of 1 February 2021. Please check with your employer about the type of worker screening application you require to ensure you pay the correct fee. Please note that application fees are non-refundable and subject to change.

Disability Worker Screening

Type of clearance	Cost	Validity
NDIS Worker Screening Clearance (paid workers)	\$117	Five years
NDIS Worker Screening Clearance (volunteers)	No charge	Five years
Queensland Disability Worker Screening Clearance (paid workers)	\$95.95	Three years
Queensland Disability Worker Screening Clearance (volunteers)	No charge	Three years

What if I need both a Worker Screening Clearance and a Blue Card?

If you require a disability worker screening check (NDIS Worker Screening or Queensland Disability Worker Screening) and a working with children check (Blue Card or exemption card), the following fees apply:

Combined Disability Worker Screening and Blue Card

NDIS Worker Screening and WWCC Blue Card (paid workers)	\$127	Five years
NDIS Worker Screening (volunteer workers) and WWCC Blue Card (paid workers)	\$10	Five years
NDIS Worker Screening (paid workers) and WWCC exemption card (paid workers)	\$117	Five years
NDIS Worker Screening (paid workers) and WWCC Blue Card or exemption (volunteers)	\$117	Five years
NDIS Worker Screening (volunteer) and WWCC Blue Card or exemption (volunteer workers)	No charge	Five years
Queensland Disability Worker Screening (paid workers) and WWCC Blue Card (paid workers)	\$105.95	Three years
Queensland Disability Worker Screening (volunteer workers) and WWCC Blue Card (paid workers)	\$10	Three years
Queensland Disability Worker Screening (paid workers) and WWCC exemption card (paid workers)	\$95.95	Three years

Queensland Disability Worker Screening (paid workers) and WWCC Blue Card or exemption (paid workers)	\$95.95	Three years
Queensland Disability Worker Screening (volunteer workers) and WWCC Blue Card or exemption (volunteer workers)	No charge	Three years

What if I am transferring from a volunteer role into paid employment?

The fee to transfer from volunteer to paid employment is calculated on a pro rata basis. The fee will be proportional to the remaining time left on your volunteer card. The paid card will be issued with the same expiry as your volunteer card.

NDIS Worker Screening – more than 4 years validity on volunteer card	\$117
NDIS Worker Screening – between 3 to 4 years validity on volunteer card	\$93.60
NDIS Worker Screening – between 2 to 3 years validity on volunteer card	\$70.20
NDIS Worker Screening – between 1 to 2 years validity on volunteer card	\$46.80
NDIS Worker Screening – less than 1 year validity on volunteer card	\$23.40
Queensland Disability Worker Screening – more than 2 years validity on volunteer card	\$95.95
Queensland Disability Worker Screening – between 1 to 2 years validity on volunteer card	\$63.95
Queensland Disability Worker Screening – less than 1 year validity on volunteer card	\$32.00

How do I pay for my worker screening application?

You can pay for your worker screening clearance application using the following payment options:

- BPOINT online at www.bpoint.com.au/pay/communities
- Bank cheque/ money order payable to: Department of Seniors, Disability Services and Aboriginal and Torres Strait Islander Partnerships, ABN 25 791 185 155

If your employer or someone else is paying for your application, they will receive an email providing payment options including BPOINT (online), cheque or money order. If they are opting to pay using the BPOINT system, ask them for the receipt number so that you can include this in your application.
